They begin to look at a simple timeline extending back to before they were born.</p>	<p><b>How have toys changed?</b> Sequencing toys into a physical timeline, children investigate artefacts from the past and begin to pose questions. Using archaeological evidence, children learn about the changes from the Stone to the Bronze Age and answer historical questions. Identifying the limitations of this type of evidence and reconstructing the life of the Amesbury Archer.</p>	<p><u>Prior Knowledge Question</u></p> <p>How am I making History?</p>	<p><b>British History 2: Why did the Romans settle in Britain?</b></p> <p>Developing their chronological awareness of AD and BC, children investigate why the Romans invaded Britain and how the Celts reacted to the invasion. 5	<p><b>British History- what was it like in Tudor England?</b> Comparing Henry VIII and Elizabeth I, children learn about the changing nature of monarchy. They learn how both monarchs tried to control the public perception of themselves using portraits and royal progresses. Using Tudor inventories to investigate whether people were rich or poor, children learn about what life was like for people living in Tudor times.</p>	<p><u>Prior Knowledge Question</u>  How hard was it to invade and settle in Britain?</p>	<p><b>What did the Greeks ever do for us?</b> Through investigating the city states of Athens and Sparta, children identify the similarities and differences between them. 6	<p><b>Why did the Maya Civilisation decline so quickly?</b> Extending their knowledge of civilisations, children will compare and contrast the Maya to Britons. They develop their chronological awareness of how the Maya fit into the timeline of mankind. Learning about the achievements of the Maya, they make contrasts to the experience of the people of Britain at this time. Deepening their understanding of the growth of empires, they also learn why the Maya Empire declined.</p>	<p><u>Prior Knowledge Question</u>  How hard was it to invade and settle in Britain?</p>	<p><b>Unheard histories: Who should go on the banknote?</b> This unit prepares the children for the challenges of Key stage 3 History. It gives them the historical skills of inference, extracting information from sources, evaluating historical figures and the opportunity, like historians, to decide their criteria for significance. The activities are well-suited to children entering Key Stage 3. **EYFS (Reception)**

**Year 1**

Placing events on a simple timeline.

Recording on a timeline a sequence of historical stories heard orally.

Sequencing up to six photographs, focusing on the intervals between events.

Placing events on a timeline, building on times studied in Year 1.

Beginning to recognise how long each event lasted.

Knowing where people/events studied fit into a chronological framework.

**Lower key stage 2**

Sequencing events on a timeline, referring to times studied in KS1 to see where these fit in.

Understanding that history is divided into periods of history e.g. ancient times, middle ages and modern.

Using dates to work out the interval between periods of time and the duration of historical events or periods.

Using BC/AD/Century.

Sequencing eight to ten artefacts, historical pictures or events.

Beginning to develop a chronologically secure knowledge of local, British and world history across the periods studied.

Placing the time studied on a timeline.

Using dates and terms related to the unit and passing of time e.g. millennium, continuity and ancient.

Noticing connections over a period of time.

Making a simple individual timeline.
